

ATA Carnet BANK INDEMNITY

IN CONSIDERATION of the Wellington Regional Chamber of Commerce (hereinafter called "the Chamber") issuing

to (1)
 an ATA Carnet (or ATA Carnets) in accordance with arrangements made under the Customs convention which entered into force for New Zealand on 28 February 1978 regarding ATA Carnets for the temporary admission of goods such as ATA Carnet (or ATA Carnets) being issued within 14 days of the

 (hereinafter called "the Bank"). The Bank hereby agrees to indemnify the Chamber in respect of all sums of money which the Chamber may be called upon to pay by way of duties and/or taxes involved in the importation of the goods subject of the ATA Carnet (during its duration) and all costs and liabilities (including currency exchange fluctuations) which may be incurred by the Chamber in ascertaining and meeting the obligations of the holder of the aforesaid ATA Carnet as may be required from time to time under the terms of the aforesaid Customs Convention.

UPON notification to the bank in writing from time to time by the Chamber that the Chamber requires payment to be made by the Bank of any part or parts of the sums due in respect of the ATA Carnet or in respect of any other liability mentioned herein under the terms of the Bank's indemnity herein evidenced, such payment or payments shall be made forthwith by the Bank and without references to

the said (1).....
 and notwithstanding any notice given to the bank not to pay same. The Bank further agrees that it will remain responsible for the payments required under the terms of this indemnity until a written notification has been received from the Chamber that the Bank's indemnity is no longer required PROVIDED THAT the Bank's liability under this indemnity shall terminate after the expiration of thirty one (31) calendar months from the date of issue of the aforesaid ATA Carnet except in respect of claims already made or notified by the Chamber to the Bank. Provided always that the Bank may at any time without being required so to do pay the Chamber

 or such lesser sum as the Chamber has advised in writing will satisfy the terms of this indemnity and upon such payment the Bank's liability under this indemnity shall be discharged.
